That letter dated 20 Sept. 2012, which Dr H initially sent to the HDC Office (following a complaint I made), had been presented with my complaint as evidence, please see the sixth PDF attachment (number '11'.) to my email of 18:51h on 09 March 2016. Altogether I sent 20 attachments with emails 1 to 4 from 18.48h to 19h on 09 March that year. Please ensure you have ALL the attachments, listed at the bottom of my complaint letter and in the emails.

Also was a further email sent on 12 April 2016, that had 3 PDFs attached (see the bottom of the letter with that same date, which was also one attachment of the total of 3). Some further correspondence from 17 July 2016 and later did mainly relate to a separate complaint under your Office's reference 41 C which is being treated separately, as I understand it. But some information sent in by me re that complaint may also have some relevance to the HDC's actions or inactions that I expressed concern about with complaint 42 2 I did in that later correspondence make mention of this.
